

Market bounced back in the green zone with a very improved turnover. Investors' participation increased as Capital Market exposure adjustment of banks about to increase for two years assured by the Finance Minister. The premier bourse of the nation opened with flying start and continued to fly till the end. Investors felt confidence and took some position in their respective holdings thus helped to break the turnover over 4 billion after eleven trading sessions. Most of the major sectors were gainer NBFI, Miscellaneous & Power mostly got the concentration. Sale pressure was not immense like the other days but buoyancy got the pace after so many days. Big cap stocks shown maturity today while Food and Jute failed. Among the other two indices DSES the shariah based index performed better than DS30.

The general gauge DSEX ended at 4475.81 with advance of +1.2% which added 51.60 points to the broad DSEX. The Turnover advanced heavily by +87.4% which was 1938 Million BDT healthier than that of previous day and finally finished the mark at 4156.42 million BDT. A total of 238 issues advanced with 44 declined and 35 remained unchanged. Sectors that improved were: Bank (+0.7%) Cement (+1.6%) Ceramics (+1.7%) Engineering (+0.2%) NBFI (+3.2%) Telecom (+0.1%) Pharmaceuticals (+0.5%) Power (+1.9%) Service (+2.9%) textile (+1.3%) Miscellaneous (+1.8%) & sectors that declined were: Food (-0.9%) Jute (-2.7%)

IFADAUTOS topped in the Volume chart with a turnover of 49.62 BDT crore. SPCL ranked top gainer chart with a price hike of +10% and IFADAUTOS topped in the loser chart with a decline of -15.5% from its prevailing price. SPCL led the way in the index mover chart while IFADAUTOS played the shatter part.
