# **Section (i): Executive summary**

# (a) About the industry:

Welding, a very effective and economical process, finds wide application in various industries such as automobiles, building & construction, pipelines, and oil & gas. The growth of the welding industry is highly dependent on the consumption of steel in various end-use industries.

The welding industry comprises welding equipment, consumables and welding services. The welding consumables market accounts for a significant share in the welding industry compared to welding equipment and welding services. Electrodes and filler metals are the key consumables used in various welding processes. Some of the key product types of welding consumables include stick electrode, solid wires, flux-cored wires, SAW wires and fluxes among others.

Demand for welding consumables in Bangladesh has been experiencing significant growth due to the constant technology advancements and substantial growth in the end-use industries. The key end-use industries driving the Bangladesh welding consumables market include-

- Shipyards, marine equipment, container, heavy duty machinery, automotive, manufacturers and repairs.
- Steel construction, construction & infrastructure contractors, defense contractors.
- Waste management, petrochemical, oil and gas industry.

# Disclosure in respect of issuance of security in Dematerialized Form:

As per provisions of the Depository Act, 1999 and regulations made there under, share of the Company will be issued in dematerialized form only and for this purpose Oimex Electrode Limited will sign an agreement with the Central Depository Bangladesh Limited (CDBL). # Conditions imposed by the Commission in the Consent Letter:

# PART-A

- 1. The Company shall go for Initial Public Offer (IPO) for 1,50,00,000 ordinary shares of Tk. 10.00 each at par totaling to **Tk. 15,00,00,000.00** (**Taka fifteen crore only**) following the Securities and Exchange Ordinance, 1969, the Bangladesh Securities and Exchange Commission (Public Issue) Rules, 2015, the Depository Act, 1999 and rules made there under.
- 2. The abridged version of the prospectus, as approved by the Commission, shall be published by the issuer in 4 (Four) national daily newspapers (two in Bangla and two in English), within **02 (two) working days** of issuance of this consent letter. The issuer shall post the full prospectus, vetted by Commission, in the issuer's website and shall also put on the websites of the Commission, stock exchanges, and the issue manager, within **3 (three) working days** from the date of issuance of this letter and shall remain posted till the closure of the subscription list. The issuer shall submit to the Commission, the stock exchanges and the issue manager a diskette containing the text of the vetted prospectus in "MS -Word" format.
- 3. The Company shall submit **40** (**Forty**) copies of the printed prospectus to the Commission for official record within **5** (**Five**) **working days** from the date of publication of the abridged version of the prospectus in the newspaper.
- 4. The issuer company and the issue manager shall ensure transmission of the prospectus and its abridged version for NRBs through email to the Bangladesh Embassies and Missions abroad within 5 (Five) working days from the date of publication of the abridged version of the prospectus in the newspaper. A compliance report shall be submitted in this respect to the Commission jointly by the issuer and the Issue Manager within 02 (Two) working days from the date of said transmission of the prospectus.
- 5. The following declaration shall be made by the company in the prospectus, namely: -

# "Declaration about Listing of Shares with the stock exchange (s):

None of the stock exchange(s), if for any reason, grants listing within **75** (**Seventy Five**) **days** from the closure of subscription, any allotment in terms of this prospectus shall be void and the company shall refund the subscription money within **15** (**Fifteen**) **days** from the date of refusal for listing by the stock exchanges, or from the date of expiry of the said **75** (**Seventy Five**) **days**, as the case may be.

In case of non-refund of the subscription money within the aforesaid **15** (**Fifteen**) **days**, the Directors of the company, in addition to the issuer company, shall be collectively and severally liable for refund of the subscription money, with interest at the rate of **2%** (**two percent**) above the bank rate, to the subscribers concerned.

If any share of Sponsors/Directors/Promoters is in paper format, it shall be handed over to securities custodian registered with the Commission and shall remain held till completion of lock-in period and the name of the securities custodian shall be furnished to the Commission jointly by the issuer and issue manager, along with a confirmation thereof from the custodian, within one week of listing of the shares with the stock exchange(s). Or they (shares of Sponsors/ Directors/ Promoters) can be demated and shall remain in lock-in under CDBL system and issuer shall submit a dematerialization confirmation report generated by CDBL and attested by Managing Director of the company along with the lock-in confirmation to the Commission within one week of listing of the shares with the stock exchange(s). In respect

- of shares other than Sponsors/Directors/Promoters the issuer will ensure their lock-in of those shares and submit a statement to this effect to the Commission.
- 15. The Company shall not declare any dividend/bonus shares before listing of its capital with any Exchange from the date of this consent for raising of capital.
- 16. The Company shall not engage itself into any merger/amalgamation or acquisition activities without taking "No Objection" from the Commission, on the scheme of the said merger/amalgamation or acquisition, as recommended by the Board of Directors, before approval by the shareholders in General Meeting.

#### PART-B

# **Application Process**

# **Step-1 (Applicant)**

- 1. An applicant for public issue of securities shall submit application/buy instruction to the Stockbroker/ Merchant Banker where the applicant maintains customer account, within the cut-off date (i.e. the subscription closing date), which shall be the 25<sup>th</sup> (twenty fifth) working day from the date of publication of abridged version of prospectus.
- 2. The application/buy instruction may be submitted in prescribed paper or electronic form, which shall contain the Customer ID, Name, BO Account Number, Number of Securities applied for, Total Amount and Category of the Applicant. At the same time:

- b) accumulate all the application/buy instructions received up to the cut-off date, deposit the amount in the "Public Issue Application Account" maintained with its bank within the first banking hour of **next working day** of the cut-off date;
- c) instruct the banker to block the account for an amount equivalent to the aggregate application money and to issue a certificate in this regard.

The Stockbroker/Merchant Banker shall prepare category wise lists of the applicants containing Customer ID, Name, BO Account Number and Number of Securities applied for, and within 03 (three) working days from the cut-off date, send to the respective Exchange, the lists of applicants in electronic (text format with tilde '~' separator) format, the certificate(s) issued by its banker, the drafts and certificates received from Non-resident Bangladeshi (NRB) and Foreign applicants and a copy of the list containing the draft information.
- 7. **On the next working day**, the Exchanges shall provide the Issuer with the information received from the Stockbroker/Merchant Bankers, the drafts and certificates submitted by Non-resident Bangladeshi (NRB) and Foreign applicants and the list containing the draft information. Exchanges shall verify and preserve the bankers' certificates in their custody.
- 8. The application/buy instructions shall be preserved by the Stockbroker/Merchant Bankers up to 6 months from listing of the securities with exchange.

# Step-3 (Issuer)

- 9. The Issuer shall prepare consolidated list of the applications and send the applicants' BOIDs in electronic (text) format in a CDROM to CDBL for verification. The Issuer shall post the consolidated list of applicants on its website and websites of the Exchanges. CDBL shall verify the BOIDs as to whether the BO accounts of the applicants are active or not.
- 10. **On the next working day**, CDBL shall provide the Issuer with an updated database of the applicants containing BO Account Number, Name, Addresses, Parents' Name, Joint Account and Bank Account information along with the verification report.
- 11. After receiving verification report and information from CDBL, the Issuer shall scrutinize the applications, prepare category wise consolidated lists of valid and invalid applications and submit report of final status of subscription to the Commission and the Exchanges within 10 (ten) working days from the date of receiving information from the Exchanges.
- 12. The Issuer and the issue manager shall conduct category wise lottery with the valid applications within 03 (three) working days from the date of reporting to the Commission and the Exchanges, if do not receive any observation from the Commission or the Exchanges.
- 13. The Issuer and issue manager shall arrange posting the lottery result on their websites within **06** (six) hours and on the websites of the Commission and Exchanges within **12** (twelve) hours of lottery.
- 14. Within **02** (two) working days of conducting lottery, the Issuer shall:

- a) send category wise lists of the successful and unsuccessful applicants in electronic (text format with tilde '~' separator) format to the respective Exchange.
- b) send category wise lists of unsuccessful applicants who are subject to penal provisions as per conditions of the Consent Letter issued by the Commission in electronic (text format with tilde '~' separator) format to the Commission and Exchanges mentioning the penalty amount against each applicant.
- c) issue allotment letters in the names of successful applicants in electronic format with digital signatures and send those to respective Exchange in electronic form.
- d) send consolidated allotment data (BOID and number of securities) in electronic text format in a CDROM to CDBL to credit the allotted shares to the respective BO accounts.

# **Step-4 (Intermediary)**

- 15. **On the next working day**, Exchanges shall distribute the information and allotment letters to the Stockbroker/Merchant Bankers concerned in electronic format and instruct them to:
  - a) remit the amount of successful (other than NRB and Foreign) applicants to the Issuer's respective Escrow Account opened for subscription purpose, and unblock the amount of unsuccessful applicants;
  - b) send the penalty amount of other than NRB and Foreign applicants who are subject to penal provisions to the Issuer's respective Escrow Accounts along with a list and unblock the balance application money;
- 16. **On the next working day** of receiving the documents from the Exchanges, the Stockbrokers/ Merchant Banker shall request its banker to:
  - a) release the amount blocked for unsuccessful (other than NRB and foreign) applicants;
  - b) remit the aggregate amount of successful applicants and the penalty amount of unsuccessful applicants (other than NRB and foreign) who are subject to penal provisions to the respective 'Escrow' accounts of the Issuer opened for subscription purpose.
- 17. **On the next working day** of receiving request from the Stockbrokers/Merchant Bankers, their bankers shall unblock the amount blocked in the account(s) and remit the amount as requested for to the Issuer's 'Escrow' account.

- 20. The Issuer, Issue Manager(s), Stockbrokers and Merchant Bankers shall ensure compliance of the above.
- 21. The bank drafts (FDD) shall be issued considering TT Clean exchange rate of Sonali Bank Ltd. on the date of publication of abridged version of prospectus.
- 22. Amount deposited and blocked in the "Public Issue Application Account" shall not be withdrawn or transferred during the blocking period. Amount deposited by the applicants shall not be used by the Stockbrokers/Merchant Bankers for any purpose other than public issue application.

- 26. The Issuer shall accumulate the penalty amount recovered and send it to the Commission through a bank draft/payment order issued in favor of the Bangladesh Securities and Exchange Commission.
- 27. The concerned Exchange are authorized to settle any complaints and take necessary actions against any Stockbroker/Merchant Banker in case of violation of any provision of the public issue application process with intimation to the Commission.

# PART-C

- 1. The issue manager shall carefully examine and compare the published prospectus and its abridged version on the date of publication with the copies vetted by the Commission. If any discrepancy is found, both the issuer and the issue manager shall jointly publish a corrigendum immediately in the same newspapers concerned, simultaneously endorsing copies thereof to the Commission and the stock exchanges concerned. In this regard, the issue manager shall submit a compliance report to the Commission within 5 working days from the date of such publications.
- 2. The fund collected through Public Offering shall not be utilized prior to listing with Exchange(s) and that utilization of the said fund shall be effected through banking channel, i.e. through account payee cheque, pay order or bank drafts etc.
- 3. The Company shall furnish status report on utilization of Public Offering proceeds audited by foreign affiliated auditors and authenticated by the board of directors to the Commission and the exchanges within 15 (Fifteen) days of the closing of each month until such fund is fully utilized, as mentioned in the schedule contained in the prospectus. The issuer shall simultaneously post the status report in its website and Exchanges shall also post the same in company information contained in websites of the Exchanges. In the event of any irregularity or inconsistency, the Commission may employ or engage any person to examine whether the issuer has utilized the proceeds for the purpose disclosed in the prospectus.
- 4. While auditing the utilization of IPO proceeds, the auditors will perform their jobs under the following terms of reference (TOR) and confirm the same in their report/certificate:

- (a) Whether IPO proceeds have been utilized for the purposes/heads as specified in the prospectus;
- (b) Whether IPO proceeds have been utilized in line with the condition (if any) of the Commission's consent letter;



Oimex Electrode Limited is engaged in manufacturing and marketing of different kinds of Welding Electrodes, Wire (G. I. Wire) and Tarkata (Nail). Wire (G. I. Wire) and Tarkata (Nail) are intermediate products of Oimex Electrode Limited. After completion of some common processes they requires some very simple jobs to be finished. Only Electrode requires some addition processes to complete as finished goods. #### **Revenue:**

Increase in installed and utilized capacity of plant and machineries, capacity utilization, supply of sufficient working capital, economics of scale, management expertise, high quality and cost leader, rising market demand increased the revenue of the Company remarkably. Specially, in 2015 and 2016 increased capital, capital machineries and utilization of capacity caused huge increase in revenue.

#### Other income:

Other income consists of wastage sales, sales of products not up to the expectation and some scraps. It is almost common and steady with sales.

#### **Total income:**

In fact combined effect of revenue and other income are reflected in total income.

#### Cost of goods sold:

Company's raw material consumption, overhead expenses and cost of production was efficiently managed and the Cost of Goods sold was in line with production. However, a slight cost reduction is seen in 2013 for which gross profit ratio increased over last year.

#### **Depreciation:**

Depreciation charged on fixed assets over its useful life. It has been calculated using diminishing balance method. Depreciation changes with changes (addition) in fixed assets year to year.

#### **Financial expenses:**

Main source of debt finance of the Company is short term & long term bank loan. Finance cost of the company consist of interest on long term & short term loan and bank charges. As the amount of bank loan changes the finance cost also changes accordingly.

#### **Change in Inventory**

Inventory turnover and inventory holding period is very much important for Oimex Electrode Limited. Change in cost, demand-supply, production, delivery of products and customer retention policy caused changes in inventory and its holding period.

#### Net profit after tax & EPS:

Net profit of the company was increased for increase of sales, gross profit and decrease of finance cost during 2016. In 2015, it increased in line with sales increased. During the years 2014 and 2013 net profit increased mainly due to increased sales volume comparative decrease in expenses.

Although net profit before and after tax increased year to year, the EPSs are not increasing because of increased no. of shares outstanding in recent years. This is mentionable here that the company changed the denomination of its shares from Tk.100.00 to Tk.10.00 each on February 02, 2014.

## Major parts of underwriting agreement:

- (i) The Company shall issue **15,000,000** Ordinary Shares of Tk. **10.00** per share for public subscription publishing a prospectus in accordance with the consent of the Bangladesh Securities and Exchange Commission and the provision of this Agreement.
- (ii) As per guideline of the Bangladesh Securities and Exchange Commission, 35% of the IPO (i.e. for Tk. 52,500,000.00) shall have to be underwritten by the underwriters, subject to the terms stated as follows:

Neither OEL nor any person acting on its behalf will, directly or indirectly, except through MTB Capital, sell, offer, attempt to offer to dispose of, or solicit any offer to buy, or otherwise approach or negotiate in respect of any matter covered by this Agreement and OEL confirms that neither OEL nor any person acting on its behalf has been engaged in any such matter prior to the date of this letter except as disclosed in writing to MTB Capital.
- 4. Any written or oral advice provided by MTB Capital in connection with its engagement is exclusively for the information of Oimex. Senior management of Oimex may not disclose such information to any third party or referred to public without the prior written consent of MTB Capital. MTB Capital agrees not to disclose, circulate or to refer to such advice publicly without the prior written consent of Oimex.
- 5. This Agreement shall be governed by, and construed in accordance with the Laws of Bangladesh. In connection with any legal proceedings arising with respect to this Agreement, Oimex and MTB Capital hereby irrevocably submit to the jurisdiction of the Bangladesh Courts.
- 6. All questions of differences whatsoever which may at any time hereinafter arise between the parties hereto or their respective representatives touching these presents or the subject matter hereof or arising out of or in connection thereto respectively and whether as to construction or otherwise shall be referred to a single arbitrator in case the parties agree upon one Arbitrator, otherwise two Arbitrators to be appointed by each party in accordance with the provisions of the Arbitration Act, 2001 (Act I of 2001) or any statutory modification thereof for the time being.

#### Section (xx): Risk factors and management's perceptions about the risks

An investment in shares involves a high degree of risk. The Company operates in a field involving some internal/external risk factors and among those some are avoidable others are beyond control which may cause loss. Investors should carefully consider all the information disclosed in this prospectus including the risks and uncertainties described below before making an investment decision in company's shares. The management of Oimex Electrode Limited perceives the risk factors which are as follows:

#### (i) Internal risk factors

#### a) Credit risk:

Credit risk is the risk of default on a debt. It may arise due to default by the borrower to pay the loan. In operating any business there are credit risks as there is always lending and borrowing between parties in the form of money and goods.

#### **Management perception:**

The Company has the ability to pay its own debts and thus no such risk will arise in near future. Credit sales and advance to suppliers, interest free advance against employees' salary may also arise credit risk. The Company provide advance, credit facility to its loyal and reliable customers who have a good track record of credit and have the ability to repay the debt. The Company has dedicated credit collection team. To mitigate the credit risk, the management of the company follows strong credit control and collections policies.

### b) Liquidity risk:

Liquidity risk is the risk that the company will not be able to meet its financial obligations as they fall due. The Company may not be able to convert its current assets to cash or cash equivalent without a loss of capital or income.

## **Management perception**

Oimex conducts liquidity management in a manner that maintains stability and flexibility in day-to-day funding activities. The Company manages its working capital in efficient way to maintain required liquidity. We are also controlling regular payment of cheque, cash inflow and outflow, maturity of deposits and our access to other funding sources as and when required.

### c) Risk associated with the issuer's interest in subsidiaries, joint ventures and associates:

#### **Management perception:**

The Company has no subsidiary, joint ventures and associates. So, no such risk arisen.

## d) Significant revenue generated from limited number of customers, losing any one or more of which would have a material adverse effect on the issuer's business:

## **Management perception:**

We are not dependent on any particular or limited number of customers to operate our business and our management is always keen to find out new buyers which boost up the sales. The Company products are distributed through district wise dealers. The dealers supply the products to different engineering, construction and developer companies and other areas where needed. We maintain a good relationship with our customers and takes feedback about their products. There is less chance to lose customers and losing any one will not affect company's profitability for its demand, high quality and competitive price.

## e) Dependency on a single or few suppliers of raw materials, failure of which may affect production adversely:

### **Management perception:**

The Company has many suppliers of raw materials and thus, it gets competitive advantage of cheaper price of raw materials. It imports raw materials from different suppliers of different countries and maintaining a good relationship with its suppliers. The management of the company is aware about the risk and continues to search for low cost raw material suppliers from different countries. Oimex has alternative options for purchasing raw materials. If any supplier is unable or disagree to supply raw materials then the company will go for next best alternative supplier immediately.

## f) Risk of generating more than 20% revenue of the issuer's sister concern or associate or subsidiary:

#### **Management perception:**

The Company has no sister concern, associate or subsidiary company, so no such risk will be arisen.

## g) Negative earnings, negative cash flows from operating activities, declining turnover or profitability, during last five years, if any:

### **Management perception:**

The Company has positive earnings, increasing turnover and profitability during the last five years. We have been operating our business efficiently and growing day by day. We have positive operating cash flow in latest two accounting years. However, there was negative operating cash flow in some years. It happened due to business growth, increased inventories and receivables, advances, deposits and prepayments in those years that affected our operating cash flow. But it was not threat for us as a going concern.

## h) Loss making associate or subsidiary or group companies of the issuer:

#### **Management perception:**

The Company has no associate, subsidiary, group companies, so no such risk arises.

#### i) Financial weakness and poor performance of the issuer or any of its subsidiary or associates:

### **Management perception:**

Oimex is financially sound and performing very well. It has no associate, subsidiary, group companies, so no such risk arises.

#### j) Decline in value of any investment:

#### **Management perception:**

The Company has no such investment. Therefore, no such risk arises.

## k) Risk associated with useful economic life of plant and machinery, if purchased in second hand or reconditioned:

#### **Management perception:**

The Company has been using brand new machineries since inception. It has no plan to purchase second hand/reconditioned machineries. Hence, no such risk arises.

## l) Adverse effect on future cash flow if interest free loan given to related party or such loans taken from directors may recalled:

#### **Management perception:**

OEL has neither provided any loan to related party nor taken any loan from such related parties. So, it is free from such risk.

m) Potential conflict of interest, if the sponsors or directors of the issuer are involved with one or more ventures which are in the same line of activity or business as that of the issuer and if any supplier of raw materials or major customer is related to the same sponsors or directors:

#### **Management perception:**

The sponsors/ directors of the company are not involved with any other business in the same line business and none of its raw material suppliers or major customers are involved in such transaction.

n) Related party transactions entered into by the company those may adversely affect competitive edge:

#### **Management perception:**

All of the transactions of the company are conducted in a normal course of business. There is no as such transaction which may adversely affect competitive edge.

o) Any restrictive covenants in any shareholders' agreement, sponsors' agreement or any agreement for debt or preference shares or any restrictive covenants of banks in respect of the loan or credit limit and other banking facilities:

### **Management perception:**

There is no such agreement with any shareholders, sponsors or any agreement relating to debt or preference shares having restrictive covenants or any restrictive covenants of banks in respect of loan or credit limit and other banking facilities.

p) Business operations may be adversely affected by strikes, work stoppages or increase in wage demands by employees:

#### **Management perception:**

The management of the company provide competitive package for all employees and offer different benefits to its employees. We believe that if employees have job satisfaction then they will give their best effort to perform their duties. The management also keeps a good relationship with its employees and workers. However, employee unrest is a part of business and it is important to deal with labor unrest efficiently. The Company has different incentive packages and policies to face those uncertainties.

q) Seasonality of the business of the issuer:

### **Management perception:**

There is no significant seasonal aspect on the company's business.

r) Expiry of any revenue generating contract that may adversely affect the business:

#### **Management perception:**

The Company did not enter into such contact with any of its customers or suppliers. So, no such risk arises.

s) Excessive dependence on debt financing which may adversely affect the cash flow:

#### **Management perception:**

Oimex is has very good balanced debt to equity ratio, debt to total asset ratio, time interest earned ratio, debt service ratio in the last five years. So, no such risk arises.

## t) Excessive dependence on any key management personnel absence of whom may have adverse effect on the issuer's business performance:

#### **Management perception:**

We believe that the business will be more fruitful when the entire work is done as a team. The Company is aware of the responsibilities risk. Each position holder has some specific job responsibility. And every key job has alternative options to perform. So, any absence of any management personal will not affect the running operation of the business.

#### u) Enforcement of contingent liabilities which may adversely affect financial condition:

#### **Management perception:**

The Company does not have any contingent liabilities which may adversely affect financial condition.

#### v) Insurance coverage not adequately protect against certain risks of damages:

#### **Management perception:**

The Company has different insurance coverage for all relating issues that are risky to operating our business.

## w) Absence of assurance that directors will continue its engagement with company after expiry of lock-in period:

#### **Management perception:**

Sponsors are directors from the inception. Oimex is a growing and profitable business and now going for listing which will increase the image, compliance issues and overall business of the company. Directors are not involved in any other organizations. So, they will continue the business after expiry of lock-in period.

## x) Ability to pay any dividends in future will depend upon future earnings, financial condition, cash flows, working capital requirements and capital expenditure:

#### **Management perception:**

Oimex is a profitable entity and it has sufficient profit in present capacity to pay dividend even for the post issue number of shares. With the expansion plan including expanded working capital need to be implemented with the net IPO proceeds, the future profit will be almost double.

## y) History of non-operation, if any and short operational history of the issuer and lack of adequate background and experience of the sponsors:

History of non-operation indicates weak operational management of the company. Non-operation leads to negative cash flow, incurring of losses and bankruptcy in worst case scenario.

## Management perception:

We know that, if operation is closed for one day it can hamper supply to our customers. In any situation, we do not compromise with our operation. Our company is operating continuously from the inception to till date. For the smooth operation, we are very serious about our responsibilities towards our employees and workers. We have power supply back up with generator for uninterrupted operation as well.

#### z) Risks related to engagement in new type of business, if any:

#### **Management perception:**

There is no as such risk relating to engagement in new type of business.

## aa) Risk in investing the securities being offered with comparison to other available investment options:

#### **Management perception:**

Oimex Electrode Limited is a growing and profitable company and it will be better and will continue in upcoming days. It has efficient management and opportunities. So, it is not risky in investing securities in comparison with other available investment options.

## bb) Any penalty or action taken by any regulatory authorities for non-compliance with provisions of any law:

#### **Management perception:**

No penalty or action has been taken against the company by any regulatory authorities for non-compliance with provisions of any law.

cc) Litigations against the issuer for Tax and VAT related matters and other government claims, along with the disclosures of amount, period for which such demands or claims are outstanding, financial implications and the status of the case:

#### **Management perception:**

There is no litigation relating to Tax, VAT or other government claims outstanding against our company.

### dd) Registered office or factory building or place of operation is not owned by the issuer:

#### **Management perception:**

Our factory building is owned by us and on our own land. The corporate office is rented for a long time and the rental is favorable to prevailing market rate.

#### ee) Lack of renewal of existing regulatory permissions or licenses:

#### **Management perception:**

All of the regulatory permission and licenses are up to date and duly renewed.

## ff) Failure in holding AGM or declaring dividend or payment of interest by any listed securities of the issuer or any of its subsidiaries or associates:

#### **Management perception:**

The Company is regular in holding AGM and paying interest in regular basis. It has sufficient retained earnings which are engaged for company business for its increased demand and growth. For further fund requirement, the company is going for public issue. It has a plan to declare good dividend to its investors after listing. It has does not have any subsidiary or associates and thus no such risk arisen.

#### gg) Issuances of securities at lower than the IPO offer price within one year:

#### **Management perception:**

Oimex Electrode Limited did not issue any shares at lower than the IPO offer price within one year.

## hh) Refusal of application for public issue of any securities of the issuer or any of its subsidiaries or associates at any time by the Commission.

#### **Management perception:**

Such cases did not happen for our company.

#### (ii) External risk factors may include among others:

### a) Interest rate risk:

Interest rate risk is associated with the fluctuations in market interest rates which cause a company's cost of debt to increase. Changes in the Government's monetary policy also tend to increase the interest rates. High rate of interest may adversely affect the operating results and financial performance of the company with additional financial charges and squeezes the profit of the company.

#### **Management perception:**

The management of the company is always aware of the interest rates at which the debts of the company are being financed. Management finances both long-term & short-term funds at competitive rates. The Company has been repaying borrowed funds on a continuous basis to reduce such interest rate risk. The present trend of interest rate is negative which is favorable for the company.

#### b) Exchange rate risk:

Most of the raw materials used by Oimex Electrodes Limited are imported from abroad against payment of foreign currency. Unfavorable volatility or fluctuations of foreign currency to BDT exchange rate may have an impact on the cost structure and profitability of the company.

#### **Management perception:**

The risk of foreign exchange cannot be eliminated fully as we require imported raw materials. However, the management is always alert in minimizing the negative impact of currency fluctuation cost by looking for new sources of raw materials and continuously negotiating with suppliers for reducing price. It always takes steps to hedge all major currency dealings to safeguard the interest of the company.

#### c) Industry risks:

#### i. Market demand:

Company's sales and revenues are depended on the aggregate demand of its products. Any economic recession, changes in requirements, national income and other related factors may cause to decline the market demand of the company products.

#### **Management perception:**

World's top class raw materials, best quality products, attractive price, strong brand loyalty of the company's products to its customers has enabled the company to capture significant market share in the sector. The Company is continuously penetrating into the market and upgrading the quality of the products to minimize the market risks.

#### ii. Raw materials and energy costs:

Instability in raw materials and energy costs may hamper the profitability of the company significantly. A recent government decision regarding escalation of electricity prices will put a huge pressure on the product cost of the local business.

#### **Management perception:**

Our management believes that efficient management of inventories, proper sourcing & timing, economic order quantity and efficient handling of credit facilities can reduce the cost of procurement. For power and electricity, Oimex Electrode Limited has own power generator for uninterrupted production. The electricity cost is same for all other competitors. So, it will be adjusted with price accordingly.

### d) Economic and political risks:

#### **Economic risks:**

The growth of the company could be adversely affected by various factors such as political or regulatory action, including adverse changes in liberalization policies, social disturbances, terrorist attacks and other acts of violence or war, natural calamities, commodity and energy prices and various other factors. Any significant changes may adversely affect our business and financials.

#### **Management perception:**

Bangladesh economy is booming for last few years. Consistent industrial growth along with increased agricultural production has made the per capita income higher than that of recent years. In addition, favorable government policies and industry friendly policies by other regulatory bodies have proved to be congenial to the economy of the country. The management of the company is aware of such risks.

#### **Political risks:**

Bangladesh is prone to serious unrest in the political condition which produces hartal, road-block and many other barriers to the business. This could also push the cost of the product upwards.

#### **Management perception:**

In the post-independence period, Bangladesh has gone through a variety of political situations. But recently, a stable political atmosphere is prevailing in the country. Both the ruling and opposition parties are committed to the betterment of the country. Political parties are thinking for growth of the country.

#### e) Market and technology related risks:

Market risks refer to the risk of adverse market conditions affecting the sales and profitability of the company. Such as, shortage in raw material supplies, inefficient labor supplies, fall in product demand, etc. which signifies the adverse external and internal business environment. Those types of risks may hamper the success of the business. Technological development may obsolescence the old machineries which may hamper the profitability of the company's overall business.

#### **Management perception:**

Oimex has own research for market and new products to retain the existing market and to attract the new customers. OEL has setup its project with modern brand new imported machineries. It has a plan for required BMRE/ expansion regularly, if required. It will continuously upgrade its machines and technology as required and any new one comes. So, the risk of obsolete technology is mitigated.

### f) Potential or existing Government regulations:

The Company operates under Companies Act, Taxation policy adopted by NBR, Bangladesh Securities and Exchange Commission (BSEC)'s Rules and Rules adopted by regulatory bodies. Any abrupt changes of the policies formed by those bodies will impact the business of the company adversely.

### **Management perception:**

Economy of Bangladesh has been developing over the decades because of business friendly Rules and Regulations adopted by the various regulatory bodies of the country. Unless any adverse policies are taken, which may materially affect the industry as a whole, the business of the company will not be affected.

Government emphasizes on the growth of local industry to meet the local need. Yet the promoters and the sponsors have endeavor to convince the policy makers for adopting favorable terms and conditions, which will eventually help the industry to compete with the low cost locations in the global arena and to save foreign currency.

## g) Potential or existing changes in global or national policies:

Changes in the existing global or national policies can have either positive or negative impacts for the company. Any scarcity or price hike or global or national policy change may hamper the profitability.

#### **Management perception:**

Political turmoil and the disturbance are bad for the economy and so for the company. The Company can prosper in situation of political stability and a congenial business environment. The management of Oimex is always concerned about the prevailing and upcoming future changes in the global or national policy and shall response appropriately and timely to safeguard its interest.

#### h) Statutory clearances and approvals those are yet to be received by the issuer:

#### **Management perception:**

We have collected all the statutory clearance to operate our business. Hence, there is no as such risk for our company.

#### i) Competitive condition of the business:

Oimex is operating in a free market economy regime. The Company might have to face hard competition from its competitors. Easily availability of global products in the local markets adds to the competition, challenging the profitability of the business.

### **Management perception:**

Bangladesh is the prime source of cheapest labor in the world, gaining comparative advantages for its industries over their global competitors. Other overhead costs are also low in Bangladesh. As a result, the company has been able to maintain its cost of products most competitive. Moreover, over the last few years the company has built a trustworthy relationship with its customers, which helps the company to almost avoid or to lower competition with others.

## j) Complementary and supplementary products or services which may have an impact on business of the issuer.

#### **Management perception:**

The Company has not faced any challenges relating to supplementary and complementary products and management are concerned with the issue. In future, if necessary, management may diversify the product to be competitive over the competitors.

#### Other risks:

Risk related to low earning base company:

### **Management perception:**

The production capacity, sales, earnings and profitability are interrelated. The continuous growth of the company and expansion in recent years is noticeable. It could manage remarkable earnings in the very recent periods.

## The proposed BMRE may not be implemented as per the company's expectation which may affect the growth and profitability of the company:

#### **Management perception:**

The Company has a plan to expand its production capacity procuring some new machinery with the net proceeds of IPO. An implementation schedule in this regards is mentioned in the draft prospectus under the caption **Use of proceeds**. Estimated time mentioned there is based on the previous experience of the company. Since the company is procuring plant and machineries on a regular basis there should not have any unusual uncertainty.

#### Risk of non-availability of electricity and other utilities:

#### **Management perception:**

The Company is getting required electricity from Rural Electrification Board (REB). In addition, the company has its own power generator for uninterrupted production. It does not require any gas. Required water is supplied by its own tube-well and distilled water plant. So, risks of non-availability of electricity and other utilities are absent here.

#### Raw material supply risk:

Any interruption of raw material may cause interruption of production and the profitability of the Company may be hampered.

## **Management perception:**

Oimex has alternative options for purchasing raw materials & chemicals. The Company maintains good relationship with its raw material & chemical suppliers. If any supplier unable or disagree to supply raw materials then the Company will go for next best alternative supplier(s) immediately.

#### Risk related to high capital based company:

#### **Management perception:**

The paid-up capital of Oimex Electrode Limited before IPO is BDT 308,920,000. Including IPO of BDT 150,000,000 the paid-up capital will be BDT 458,920,000. On the other hand, it has bank loan of BDT 130,132,663 which is only 42.13% of pre-IPO and 28.36% of post-IPO paid-up capital. Management of OEL think that it is not a high capital intensive company. They are aware of the issue and will take necessary action if and when necessary.

The profit of the Company, subject to any special right relating thereto created or authorized to be created by the Memorandum and subject to the provisions of the Articles of Association, shall be divisible among the members in proportion to the amount of capital paid-up on the shares held by them respectively.
- ii. No large dividend shall be declared than is recommended by the Directors, but the Company in its General Meeting may declare a smaller dividend. The declaration of Directors as to the amount of Net profit of the Company shall be conclusive.
- iii. No dividend shall be payable except out of the profits of the Company or any other undistributed profits. Dividend shall not carry interest as against the Company.
- iv. The Directors may from time to time pay the members such interim dividend as in their judgment the financial position of the Company may justify.
- v. A transfer of shares shall not pass the right to any dividend declared thereon before the registration of transfer.
- vi. No limitation in payment of dividend is stipulated in any debt instrument or otherwise.

## (d) Other rights of the securities holders:

In terms of the provisions of the Companies Act 1994, Articles of Association of the Company and other relevant rules in force, the shares of the Company are transferable. The Company shall not charge any fee, other than Government duties for registering transfer of shares. No transfer shall be made to a minor or person of unsound mind.

Financial statements will be prepared in accordance with the International Accounting Standards consistently applied throughout the subsequent periods and present with the objective of providing maximum disclosure as par law and International Accounting Standard to the shareholders regarding the financial and operational position of the company. The shareholder holding minimum of 10% shares of paid-up capital of the company shall have the right to requisition extra ordinary General Meeting of the company as provided for the section 84 of the Companies Act 1994.

## 2.08 Functional and presentation currency

The financial statements are prepared and presented in Bangladesh Currency (Taka), which is the company's functional currency. All financial information presented has been rounded off to the nearest Taka except where indicated otherwise.

## 2.09 Use of estimates and judgments

The preparation of financial statements in conformity with Bangladesh Accounting Standards requires management to make judgments, estimates and assumption that affect the application of accounting polices and the reported amount of assets, liabilities, income and expenses, and disclosure requirements for contingent assets and liabilities during and at the date of the financial statements. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions of accounting estimates are recognized in the period in which the estimate is revised and in any future periods affected as required by BAS 8: Accounting policies, changes in Accounting Estimates and Errors. In particular, significant areas of estimation uncertainty and critical judgment in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements include depreciation, inventory valuation, accrued expenses and other payables.

#### 2.10 Standards, amendments or interpretations which became effective during the year

During the period certain amendments to Standards and new interpretations became effective however they did not have any material effect on the financial statements of the Company.

## 2.11 New/revised accounting standards, amendments to published accounting standards, and Interpretations that are not yet effective

The following new standards, amendments and interpretations of approved accounting standards are only effective for annual periods beginning from the dates specified below and have not been early adopted by the company.

- Amendments to IAS 12: income tax, deferred tax on investment property (effective for annual periods beginning on after 01 January 2012). The 2010 amendment provides an exception to the measurement principle in respect of investment property measured using the fair value model in accordance with IAS 40 Investment property. The measurement of deferred tax assets and liabilities, in this limited circumstance, is based on a rebuttable presumption that the carrying amount of the investment property will be recovered entirely through sale. The presumption can be rebutted only if the investment property is depreciable and held within a business model whose objective is to consume substantially all of the asset's economic benefits over the life of the asset. The amendment has no impact on financial statements of the Company.
- IAS 19: (Amendment) regarding defined benefit plans (effective for periods beginning on or after July 1, 2014) amendments that require actuarial gains and losses to be recognized immediately in other comprehensive income; this change will remove the corridor method and eliminate the ability for entities to recognize all changes in the defined benefit obligation and in plan assets in profit or loss, which currently is allowed under IAS 19: and that the expected return on plan assets recognized in profit or loss is calculated based on the rate used to discount the defined benefit obligation. The Company is yet to assets the full impact of the amendment.
- Presentation of items of Other Comprehensive income (Amendments to IAS-1) (effective for annual periods beginning on or after 1 July 2012). The amendments require that an entity present separately the items of other comprehensive income that would be reclassified to profit or loss in the future it certain conditions are met from those that would never be reclassified to profit or loss. that standard. If these items do not meet the definition, then they are accounted for using IAS 2 Inventories.

- IAS 32: Financial Instruments: Presentation - is amended to clarify that IAS 12- Income Taxes applies to the accounting for income taxes relating to distributions to holders of an equity instrument and transaction costs of an equity transaction. The amendment removes a perceived inconsistency between IAS 32 and IAS 12.

#### 3.00 SIGNIFICANT ACCOUNTING POLICIES

#### 3.01 Principal Accounting Policies

The Accounting policies and methods of computation used in preparation of the financial statements for the year ended June 30, 2016 are consistent with those adopted in the financial statements for the year ended June 30, 2015 except for a change in accounting policy.

## 3.02 Property, Plant & Equipment

#### (a) Recognition and Measurement

Property, plant and equipment are capitalized at cost of acquisition and subsequently stated at cost or valuation less accumulated depreciation in compliance with the requirements of BAS-16: Property, Plant and Equipment. The Cost of acquisition of an asset comprises its purchase price and any directly attributable cost of bringing the assets to its working condition for its intended use inclusive of inward freight, duties and non refundable taxes. Capital work-in-progress represents cost of Effluent Treatment Plant & civil work-in-progress for such plant. No depreciation is charged on Land and Land Development.

#### (b) Pre-operating expenses and borrowing costs

In respect of major project involving construction, related pre-operational expenses from part of the value of assets capitalized. Expenses capitalized also include applicable borrowing cost considering the requirement of BAS 23: Borrowing Costs.

#### (c) Subsequent expenditure

The company recognizes in the carrying amount of an item of property, plant and equipment the cost of replacing part of such an item when that cost is incurred, it is probable that the future economic benefits embodied with the item will flow to the company and the cost of the item can be measured reliably. Expenditure incurred after the assets have been put into operation, such as repairs and maintenance is normally charged off as revenue expenditure in the period in which it is incurred. In situation where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefit expected to be obtained from the use of the fixed assets, the expenditure is capitalized as an additional cost of the assets. All other costs are recognized to the profit and loss account as expenses if incurred. All upgradation/enhancement are generally charged off as revenue expenditure unless they bring similar significant additional benefits.

#### (d) Disposal of fixed assets

On disposal of fixed assets, the cost and accumulated depreciation are eliminated and gain or loss on such disposal is reflected in the statement of profit or loss and other comprehensive income, which is determined with reference to the net book value of the assets and net sales proceeds.

#### (e) Depreciation

As per BAS 16, Property, Plant & equipment, each part of an item of property plant & equipment with cost that is significant in relation to the total cost of the item has been depreciated separately. Depreciation is a systematically allocation of depreciable assets over its useful life and charge to profit and loss unless it is included in the carrying amount of another

assets. Depreciation has been calculated using diminishing balance method at the following rates:

Depreciation is provided on all fixed assets except land and land development. Depreciation charged for the month of acquisition on addition of fixed assets. Total depreciation is distributed as under:

#### (f) Impairment of assets

The company reviews the recoverable amount of its assets other than inventories at each reporting date. If there exist any indication that the carrying amount of assets exceeds the recoverable amount, the company recognized such impairment loss in accordance BAS-36. No such indication of impairment has been observed till the end of the year.

## 3.03 Financial liability

Financial liabilities are recognized initially on the transaction date at which the company becomes a party to the contractual provisions of the liability. The company derecognizes a financial liability when its contractual obligations are discharged or cancelled or expire. Financial liabilities include payable for expenses, liability for capital expenditure and other current liabilities.

## 3.04 Inventories

Inventories are valued at the lower of cost or net realizable value with cost determined by weighted average cost basis. The cost of inventories comprises of expenditure incurred (raw materials, work-in process, dyes & chemicals, packing materials, store and spares and stock-in transit.) in the normal course of business in bringing the inventories to their present location and condition. Net realizable value is based on estimated selling price less any further costs expected to be incurred to make the sale. Stock in hand at year end date have been physically verified by the management in the presence of the auditors' representatives and duly reconciled.

#### 3.05 Provision

A provision is recognized in the statement of financial position when the company has a legal or constructive obligation as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provision is ordinarily measured at the best estimate of the expenditure required to settle the present obligation.

#### 3.06 Earnings per share (EPS)

#### **Earnings per share (EPS)**

The company calculates Earning Per Share (EPS) in accordance with BAS 33 "Earnings Per Share" which has been shown on the face of statement of profit or loss and other Comprehensive Income and the computation of EPS is stated in Note - 28 of the financial statements.

#### **Basic Earnings**

This represents earnings for the period attributable to the ordinary shareholders. As there no preference dividend, minority interest or extra ordinary items, the net profit for the year has been considered as fully attributable to ordinary shareholders. Basic earnings per has been calculated by dividing the net profit or loss by the weighted average number of ordinary share outstanding during the year.

#### **Diluted Earnings Per Share (DEPS)**

Diluted EPS is determined by adjusting the profit or loss attributable to ordinary shareholders and weighted average number of ordinary shares outstanding, for the effect of all dilutive potential ordinary shares. Dilution of EPS is applicable for these financial statements as there were potential ordinary shares during the relevant period.

## 3.07 Revenue Recognition

Revenue from net sales of the company represents invoiced value of sale of finish goods (Electric goods) which are recognized after considering the conditions, set in paragraph 14 of BAS 18: "Revenue". Revenue from the sale of goods is recognized when all the following conditions are satisfied:

- the company has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the company retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the company; and
- the cost incurred or to be incurred in respect of the transaction can be measured reliably.

#### Other income:

All other income is recognizing when the Company's right to receive such income has been reasonably determined and all conditions precedent is satisfied.

#### 3.08 Foreign Currency Transaction/Translation

Foreign currency transactions are translated into Bangladeshi Taka at the exchange rates ruling at the transaction dates according to BAS 21: "The effect of changes in Foreign Exchange Rates". Monetary assets and liabilities denominated in the foreign currencies are translated at prevailing rates on the balance sheet (financial position) date. Non monetary assets and liabilities denominated in foreign currencies, which are related at historical cost, are translated into Bangladesh Taka at the exchange date ruling at the date of transactions. Foreign exchange fluctuation gain/losses are charged to Statement of profit or loss and other Comprehensive Income for the respective period.

### 3.09 Financial Expenses

Finance cost comprises interest expenses on bank loan, bank charge and other borrowings. All finance expenses are recognized in the Statement of profit & loss and other comprehensive income the requirement of BAS-23.

#### 3.10 Financial assets

Financial assets of the company include cash and cash equivalents, accounts receivable and other receivables.

#### (a) Accounts Receivables

Accounts receivables are recognized initially at invoice value and subsequently measured at the remaining amount less allowance for doubtful receivable at the year end, if any. Receivables from foreign currency transactions are recognized in Bangladeshi Taka using exchange rates prevailing on the date of transaction.

#### (b) Advance, deposits and prepayments:

- Advance is initially measured at cost. After initial recognition, advances are carried at cost less deductions, adjustments or charges to other account heads.
- Deposits are measured at payment value.
- Prepayments are initially measured at cost. After initial recognition, prepayments are carried at cost less charges to statement of profit or loss and other comprehensive income.

#### (c) Cash and Cash Equivalents

Cash and cash equivalents consist of cash in hand and with banks on current and deposit accounts and short term investments which are held and available for use by the company without any restriction. There is insignificant risk of change in value of the same.

#### 3.11 Taxation

#### **Current Tax**

Current tax is the expected tax payable on the taxable income for the financial year, using tax rates enacted or subsequently enacted after the reporting date and any adjustment to tax payable in respect of previous years. Provision for taxation is calculated on the basis of applicable current tax rate and incompliance with Finance Act. 2015.

#### **Deferred Tax**

The company has decided to adopt policy of recognition of deferred tax in accordance with the Bangladesh Accounting Standard (BAS-12), deferred tax is provided using the liability method for temporary difference between the carrying value of fixed assets as per accounts and the corresponding income tax written down value. Deferred tax is calculated at the effective income tax rate prevailing at the statement of financial position date.

### 3.12 Provisions

As per "BAS 37: Provisions, Contingent Liabilities and Contingent Assets' a provision recognized on the date of financial position if, as a result of past even Company has a present obligation that can be estimated reliably, and it is probable the outflow of economic benefits will be required to settle the obligation.

A provision is recognized if, as a result of a past event, the company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefit will be required to settle the obligation.

#### 3.13 Segment Reporting

No segmental reporting is applicable for the company as required by "BFRS - 8: Operating Segment" as the company operates in a single industry segment and within as geographical segment.

#### 3.14 Event after Statement of Financial Position Date

In compliance with the requirements of BAS-10: Events after the reporting period, events after the reporting period that provided additional information about the company's position at the statement of financial position date are reflected in the financial statements and events after the statement of financial position date that are not adjusting events are disclosed in the notes when material.

#### 3.15 Comparative information:

Comparative information have been disclosed in respect of the previous year for all numerical information in the financial statements including narrative and descriptive information when it is relevant for understanding of the current year's financial statements.

#### Re-arrangement

Comparative figures have been rearranged wherever considered necessary to ensure better comparability with the current period without causing any impact on the profit and value of assets and liability as reported in the financial statement.

#### 3.16 Revaluation of assets

The company has not been revalued its assets any time since inception.

#### 3.17 Employee benefits

The company maintains defined benefit plan for its eligible permanent employees. The eligibility is determined according to the terms and conditions set forth in the respective deeds. The company has accounted for and disclosed employee benefits in compliance with the provisions of BAS 19: Employee Benefits. The cost of employee benefit is charged off as revenue expenditure in the period to which the contributions relate.

The company's employee benefits include the following:

#### **Short Term Employee Benefits**

Short-term employee benefits include salaries, bonuses etc. Obligations for such benefits are measured on an undiscounted basis and are expensed as the related service is provided.

#### Worker's profit participation fund (WPPF)

The company makes a regular allocation of 5% on net income before charging such expense to this funds and payment is made to the workers as per provisions of Labour Laws 2006.

#### 3.18 Going Concern

The company has adequate resources to continue its operations for foreseeable future. For this reason the directors continue to adopt the going concern basis in preparing the accounts. The resources of the company are sufficient to meet the present obligation of its existing businesses and operations.

## 3.19 Related Party Disclosures

The company carried out a number of transactions with related parties in the normal course of business and on arms' length basis. The information as required by BAS 24: Related Party Disclosures has been disclosed in a separate note (note no: 34) to the accounts.

#### 3.20 Statement of cash flows

The statement of cash flows has been prepared in accordance with the requirements of BAS 7: Statement of cash Flows. The cash generating from operating activities has been reported using the Direct Method as prescribed by the securities and Exchange Rules, 1987 and as the benchmark treatment of BAS 7 whereby major classes of gross cash receipts and gross cash payments from operating activities are disclosed.

#### 3.21 Financial Risk Management Policies

The company is exposed to normal business risks from changes in market interest rates and currency exchange rates and from non-performance of contractual obligations by counterparties. The company does not hold or issue derivative financial instruments for speculative or trading purposes.

#### **Interest Rate Risk**

The company has no significant risk of fluctuations in interest rates.

#### **Foreign Currency Risk**

The company is exposed to foreign currency risk relating to purchases which are denominated in foreign currencies.

#### Credit Risk

Credit risk is the potential financial loss resulting from the failure of a customer or counterparty to settle its financial and contractual obligations to the company as and when they fall due.

Management has a credit policy in place and the exposure to credit risk is monitored on an ongoing basis. Credit evaluations are performed on all customers requiring credit over a certain amount. At the reporting date there were no significant concentrations of credit risk. The maximum exposure to credit risk is represented by the carrying amount of each financial asset in the statement of financial position. However, due to the large number of parties comprising the group's customer base, Management does not anticipate material losses from its debt collection.

#### **Liquidity Risk**

The company monitors its liquidity risk and maintains a level of cash and cash equivalents deemed adequate by management to finance the company operations and to mitigate the effects of fluctuations in cash flows.

#### **Fair Values**

The fair value is the amount for which an asset could be exchanged, or a liability settled, between knowledgeable, willing parties in an arm's length transaction. The fair value of trade and other short-term receivables are taken to approximate their carrying value. The fair value of financial assets and liabilities approximate their carrying value.

## Step-1 (Applicant)

- 1. An applicant for public issue of securities shall submit application/buy instruction to the Stockbroker Merchant Banker where the applicant maintains customer account, within the cut-off date (i.e. the subscription closing date), which shall be the **25th** (**twenty fifth**) working day from the date of publication of abridged version of prospectus.
- 2. The application/buy instruction may be submitted in prescribed paper or electronic form, which shall contain the Customer ID, Name, BO Account Number, Number of Securities applied for, Total Amount and Category of the Applicant. At the same time:
  - a) Other than non-resident Bangladeshi (NRB) and Foreign applicants shall make the application money and service charge available in respective customer account maintained with the Stockbroker/Merchant Banker. No margin facility, advance or deferred payment is permissible for this purpose. - 7. **On the next working day**, the Exchanges shall provide the Issuer with the information received from the Stockbroker/Merchant Bankers, the drafts submitted by Non-resident Bangladeshi (NRB) and Foreign applicants and the list containing the drafts and certificates information. Exchanges shall verify and preserve the bankers' certificates in their custody.
- 8. The application/buy instructions shall be preserved by the Stockbroker/Merchant Bankers up to 6 months from listing of the securities with exchange.

## Step-3 (Issuer)

- 9. The Issuer shall prepare consolidated list of the applications and send the applicants' BOIDs in electronic (text) format in a CDROM to CDBL for verification.   - b) send category wise lists of unsuccessful applicants who are subject to penal provisions as per conditions of the Consent Letter issued by the Commission in electronic (text format with tilde separator) format to the Commission and Exchanges mentioning the penalty amount against each applicant.
  - c) issue allotment letters in the names of successful applicants in electronic format with digital signatures and send those to respective Exchange in electronic form.
  - d) send consolidated allotment data (BOID and number of securities) in electronic text format in a CDROM to CDBL to credit the allotted shares to the respective BO accounts.

## **Step-4 (Intermediary)**

- 15. **On the next working day**, Exchanges shall distribute the information and allotment letters to the Stockbroker/Merchant Bankers concerned in electronic format and instruct them to:


## Management additional disclosures:

1. It appears that MTB Capital Ltd., the Issue Manager of the proposed issue has 5.92% share of your company in the name of MTB Capital Discretionary Portfolio Management. It contradicts the requirement of the rule 3(2)(d) of the Bangladesh Securities and Exchange (Public Issue) Rules, 2015. Provide explanation with documents.

**Management response:** MTB Capital Discretionary Portfolio Management is a product of MTB Capital Limited, the Issue Manager of our proposed issue. Under this portfolio account both individuals and institutional investors hold 5.92% shares of our OEL. MTB Capital Limited does not hold any shares of Oimex Electrode Limited. They invest their own fund through the BO ID namely **MTB Capital Own Portfolio Management.** As this is not their own investment, it does not contradict the requirement of the rule 3(2)(d) of the Bangladesh Securities and Exchange (Public Issue) Rules, 2015.

2. It is observed from the draft prospectus that the company is producing welding electrode along with G. I. wire and nail (Parek) which is a contravention to the Condition No. 2 of the expired Environment Clearance Certificate issued on 25-11-15 where it is stated that the company shall not produce any metal product except electrode. Explain your position with documents.

**Management response:** Oimex Electrode Limited is producing G. I. Wire, Nail (Parek) and different category of Welding Electrodes. All the products are produced from the same metal (Electrode grade wire rod). G. I. Wire and Nail (Parek) are intermediate products and requires a shorter production process than Welding Electrodes. The flow chart of the production process is as follows:



The environment clearance certificate includes some conditions which are common. Condition no. 2 is one of those conditions. OEL is not using any other metal in the production process. The authority is satisfied and providing us the renewal copy regularly.

3. It is observed that the company was incorporated on 18th September, 2005 as a private limited company but it started it's commercial operation on 21st March, 2010 i.e. 4.5 years later of it's incorporation. Explain the reason of starting commercial operation after 4.5 years of incorporation.

**Management response:** Oimex Electrode Limited was incorporated on September 18, 2005 as a private limited company under Registrar of Joint Stock Companies and Firms (RJSC) vide registration number C-59061/(1067)/05 under the companies Act 1994. After successful incorporation, we procured machineries from China but due to some unavoidable circumstances we had to change machineries and imported from India again. Technical knowhow and hiring sufficient skilled people was a challenge and required lots of time. Finally, power supply crisis at that time delayed our commercial production.

#### Auditor's additional disclosures required to submit and incorporated in the prospectus.

1. It appears from auditors' report under Section 135(1) Para (1) Part II of the Third Schedule of Company's Act 1994 that net cash provided from operating activities shows a negative balance of Tk. 34,94,431/-, 4,78,05,842/- and 1,43,47,411/- for the year ended on June 30, 2014, 2013 and 2012 respectively which is a threat for the company to continue as a going concern. Provide auditors' explanation on the above with reasons for such negative cash flows in those years.

Auditors' response: Conceptual framework of IFRS states that a going concern is a business that functions without the threat of liquidation for the foreseeable future, usually regarded as at least within 12 months. It implies for the business the basic declaration of intention to keep running its activities at least for the next year, which is a basic assumption to prepare financial statements. Hence, the declaration of going concern means that the entity has neither the intention nor the need to liquidate or curtail materially the scale of its operations. Oimex Electrode Limited is expanding its business continuously and we found that the inventory and receivables increased with the increased sales. It has negative operating cash flow but positive in overall cash flow statements for the year ended June 30, 2012, 2013 & 2014 and positive operating cash flow in the year ended June 30, 2015 and 2016. In accordance with BSA-570, Para-10 under clause-A 2 (Risk Assessments Procedures and Related Activities) about Going Concern issues, there are lots of indicators/ events or conditions that make cast significant doubt about the certainty of the enterprise as Going Concern. But all the indicators are not at all inclusive nor do the existences of one or more items always signify that a material uncertainty exists. In view of the above, it is not a threat to continue its operation as a going concern.

2. The Company has not conducted impairment test of assets since its inception. In accordance with the Paragraph 9 of BAS 36 "Impairment of Assets" "An entity shall assess at the end of each reporting period whether there is any indication that an asset may be impaired. if any such indication exists, the entity shall estimate the recoverable amount of the asset.

It is observed from the audited financial statements that the Company has not conduct impairment test of assets, which is a non-compliance with the Paragraph 9 of BAS 36. You are requested to clarify your position regarding non-compliance with the Paragraph 9 of BAS 36.

**Auditors' response:** The management has not conducted impairment test of assets up to year ended June 30, 2015 in accordance with the Paragraph 9 of BAS 36 "Impairment of Assets". We have reviewed the documentation and found that the plant and machineries they are using were installed in brand new condition and are maintaining properly. From the year 2016 the management is conducting impairment test of assets which is included in the note no. 3.02(f) of the audited financial statements.

3. It is observed that the company has not prepared statement of cash flows and statement of changes in equity in the Financial Statements prepared for the year ended June 30, 2012 and June 30, 2013. Provide auditors' clarification regarding how the financial statements prepared for those years complied with the requirements of Bangladesh Financial Reporting Standards (BFRs) and Bangladesh Accounting Standards (BASs) and how the financial statements of those years have presented true and fair view of the company's financial position and its state of affairs as on June 30, 2012 and June 30, 2013.

**Auditors' response:** We have audited the financial information of Oimex Electrode Limited for the year ended 30 June 2016. The financial statements for the year ended June 30, 2015, 2014 2013 are audited by Mohammad Ata Karim & Co. Chartered Accountants, for the year ended June 30, 2012 audited by Shafiq Mizan Rahman & Augustine, Chartered Accountants.

We have confirmed the balance of credit sales in compliance with BSA on test basis.

7. It is observed from Note 20.01 to the financial statements for the period ended on June 30, 2016 that the company's sales revenue from welding Electrode (main product) during the year was only Tk.5,73,97,622/- which was only 14% of its sales revenue. Remaining 86% sales revenue were from selling of G.I. Wire and Nail (Parek) which are not legal business of the company as per Condition No.2 of Environment Clearance Certificate No.22.02.4001.016.43.161.13-282 dated November 25, 2015. As such, mention how the company will continue its operations for foreseeable future with only 14% sales revenue from legal business;

**Auditors' response:** We have discussed the matter with the management of the Company and they have given us the following reply in this regards,

Quote ... all three products- Welding Electrode, G. I. Wire and Neil (Parek) are our main products and are produced from the same metal (Electrode grade wire rod). So, we are not producing any illegal products.

Oimex Electrode Limited is producing high quality products at a reasonably lower cost due to low cost of labor and other direct costs compared to other producers. When the market demand of any of its products increases, we increase the production of that particular products to maintain our market, customers, dealers and profitability. The sales revenue percentage changes time to time. The management of the Company is aware of the matter and think that it will not create any problem to continue its operations in the foreseeable future - Unquote.

8. It is observed that the Company has made some re-arrangements/ re-statements of its financial data. Mention the years in which such re-arrangements/ re-statements were made, basis and impact on NAV and EPS.

**Auditors' Response:** Some of the accounting heads in the financial statements of Oimex Electrode Limited required rearrangement/ reclassification in the year 2013-2014 and 2014-2015. The reclassification was made for better understanding of the financial statements and complying the Paragraph 41 of Bangladesh Accounting Standards (BAS) 1. None of the aforesaid reclassification impacted the NAV and EPS of the relevant year(s) of the Company.

9. It appears that chairman of the company has received Tk. 12 lacs during the year 2016 as remuneration. Explain with reasons whether this payment contradicts the provision of the Section 104 of the Companies Act 1994.

**Auditors' response:** The Chairman of Oimex Electrode Limited received a monthly remuneration of Tk. 1,00,000/- (Taka one lac) only totaling to Tk. 12,00,000/- (Taka twelve lacs) only during the year ended June 30, 2016 for her service to the Company. The members of the Company approved the said remuneration in 9<sup>th</sup> Annual General Meeting (AGM). So, it does not contradict the Section 104 of the Companies Act 1994.

10. State whether remuneration paid to chairman during the year 2013, 2014, 2015 & 2016 has shown in information furnished to Income Tax Authority under Section 108 of the Income Tax Ordinance, 1984. If not, how this figure is shown to the Income Tax Authority.

**Auditors' response:** The Chairman of the receiving remuneration from July 01, 2014. The Company deduct source tax from the remuneration of the Chairman before disbursing the amount and deposit the same to the government exchequer.

11. Break-up of land and land development expense with an explanation why land development expense is required.

**Auditors' response:** The Company own and physically possesses 500.90 decimals of land. To make the land usable, the Company made the development expenses. The total land included some low lands that required filling and total land required pilling. For security reason it made a 10 feet high boundary wall surrounding the land. There were some tree plantation and the costs of which was included in the land development expenses.

It is observed from Note 38 to the financial statements for the period ended on June 30, 2015 that the current production capacity utilization of the company was 87.52% and 36.43% as on June 30, 2015 and June 30, 2014 respectively. There was 51.09% increase in current production capacity utilization comparing to the previous year. You are requested to clarify your position in this regard.

**Auditors' response:** Based on the examining the relevant books and documents of Oimex Electrode Limited we came to know that the production capacity utilization of its installed capacity was 36.43% in 2014 which was 87.52% in 2015. The Company was suffering from working capital. In 2015, sufficient working capital was supplied. Increased management expertise, economies of scale also causes increased installed capacity utilization. Some addition in machineries and proper maintenance are also important for the said increased capacity utilization.

15. It appears from Note 7 to the financial statements for the period ended on June 30, 2015 that there was an advance of Tk. 2,57,80,000/- which was Tk. 3,55,20,000/- on June 30, 2014. It is also appeared from fixed asset schedule that there is an addition to land & land development of Tk. 97,40,000/- which is adjusted with the advance amount given in previous period. But it also appears from Cash Flow Statements prepared for the year ended June 30, 2015 that Tk.97,40,000 against addition of land & land development is shown as cash outflow under the head cash flow from investing activities which is not clear.

**Auditors' response:** The management complied the Paragraph 41 of Bangladesh Accounting Standards (BAS)-1 while preparing the cash flow statements for the year ended June 30, 2016. It causes the rearrangements in the cash flow statement for the year ended June 30, 2015. Moreover, in the cash flow statements for the year ended June 30, 2015, **Tk. 9,740,000** of capital work in progress was wrongly added to Acquisition of fixed assets. It is corrected accordingly and incorporated.

16. It is observed from the audited financial statements that the inventory holding period has been decreased to 117 days for the year ended 30 June 2015 whereas it was 206 days for the year ended 30 June 2014. It has indicated that inventory holding period in 2015 has registered 89 days reduction over the prior year.

In the above context, you are requested to clarify the reason of such decline.

**Auditors' response:** Inventory turnover and inventory holding period is very much important for a manufacturing entity. It depends on inventory management, cost, demand supply etc. Efficient inventory management, cost reduction, increased demand of its products, smooth delivery, customer retention policy, etc. of Oimex Electrode Limited caused a reduction of inventory holding period by 89 days in 2015 from 2014. The management has taken initiative for further reduction of holding period in future years.

17. It is observed from the audited financial statements that the revenue of the company for the year ended June 30, 2014 was Tk.126,540,200 and for the year ended June 30, 2015 was Tk.386,709,515 which is about 206% higher than that of previous period. Explain the reason of such unusual increase of sales during FY 2014-15.

**Auditors' response:** Shareholders' equity of Oimex Electrode Limited was 274% in 2015 over 2014. The production capacity utilization of the Company was 36.43% in 2014 which stood 87.52% in 2015. Oimex Electrode Limited manages to achieve a continuous growth in sales over the periods due to management expertise, economics of scale, increased capacity utilization through adequate working capital facility, lower cost of labor, expansion of market and raw materials. Moreover, quality products at reasonable price and value added products attract buyers and caused significant increase in revenue of the Company.

18. It is observed from the audited financial statements that accounts receivables of the company as on June 30, 2014 was Tk.4,34,60,000 and on June 30, 2015 was Tk. 10,35,50,230/- which is about 138% higher than that of 2014 which is an indication of the company's low working capital and also inability to pay debts. Provide justification regarding this.

**Auditors' response:** Any amount remain unpaid from the customers at the end of any financial year creates accounts receivables. As the volume of sales increase the receivables may increase. The revenue of Oimex Electrode Limited in 2015 was 3 times (300%) that of 2014 and accounts receivables increased by 138% in 2015 over that of 2014. As credit sales are a market practice, the Company cannot avoid it. The management of the Company is aware of the matter and could reduce it in 2015. The accounts receivable to sales ratio in 2015 is 26.78% where it was 34.35% in 2014.

19. NPAT, EPS for the year ended 30-06-2016 charging depreciation on land development from inception.

**Auditors' response:** Depreciation is not applicable on land and land development of Oimex Electrode Limited. Therefore, NPAT and EPS for the year ended 30-06-2016 charging on land and land development from inception will remain unchanged.

20. Compliance of para 59 of BAS-16 regarding changing depreciation on land development expenses.

**Auditors' response:** According to BAS-16 para 59 "If the cost of land includes the costs of site dismantlement, removal and restoration, that portion of the land asset is depreciated over the period of benefits obtained by incurring those costs. In some cases, the land itself may have a limited useful life, in which case it is depreciated in a manner that reflects the benefits to be derived from it."

Land and land development cost of Oimex Electrode Limited does not include any cost of site dismantlement, removal or restoration. Thus, no depreciation was charged on land and land development cost of OEL.

21. Compliance of condition 5, 11 of the letter issued by the environment Authority dated 14-11-2013.

24. It appears from note 3.04 that the auditor has physically verified the inventory but not cash-in-hand. Explain;

**Auditors' response:** We have physically verified cash in hand at year end date (June 30, 2016) but unintentionally it was not mentioned in the note to the financial statements.

25. Updated status of capital Work-In-Progress.

**Auditors' response:** Capital work in progress as on June 30, 2016 was Tk.49,765,251 and Tk.40,459,687 was transferred to fixed assets (Building) in that year. As on December 31, 2016 it stood at Tk.57,943,124.

26. You have not mentioned licensed capacity of company as per requirement of schedule XI, part II, para 7 of the Companies Act, 1994.

**Auditors' response:** The installed capacity as mentioned in note number 35 of the financial statements is the licensed capacity. Now, due correction is made as per requirement of schedule XI, Part II, Para 7 of the Companies Act 1994.

27. You have provided a certificate on 28-08-2016 (Page 158 of the prospectus) regarding payment of Taxes. But the figure shown there in for the year ended 30-06-2016, 30-06-14 do not agree with the original accounts. Explain.

**Auditors' response:** Typo error. We apology. Due correction is made.

28. In note 2.04 you have stated about compliance with the requirements of notification ref# SEC/CMMRRC/ dated 04-06-2008. But there is no notification is in existence. Explain.

**Auditors' response:** Unintentional typing mistake. We regret.

29. In note 2.04 (b) you have stated that accounting policies have been stated in notes marked from 3.00 to 3.21. But it appears that 'Accounting Policies Adopted by the company' are disclosed in note 2.00.

**Auditors' response:** It should be from note number 2.00 to 3.21 instead of 3.00 to 3.21. Typo error. We apology.

30. In note 3.19 you have mentioned that 'Related Party Disclosures' are made in note no: 34. But note 34 do not discloses such information.

**Auditors' response:** Related party transaction is disclosed in note number 33 not in 34. Unintentional typo error.

31. Explain the term 'MPI Loan' as disclosed in note 15.00.

**Auditors' response:** MPI stands for Murabaha Post Import (MPI) Investment in Islami Banking system.

32. You have mentioned in note 3.01 that accounting policies are consistently applied except for a change in accounting policy. But you did not mention what changes are made.

Auditors' response: No accounting policy was changed in our audit period. It is our typing mistake.

33. In note 2.04 (c) you have mentioned that BAS No.11 (Construction Contracts) is applicable for the company. State where it is applied in the accounts.

**Auditors' response:** We have wrongly mentioned that BAS No.11 (Construction Contracts) is applicable for the company. But it is not applicable for Oimex Electrode Limited. Due correction made.

34. You have mentioned in note 12.00 that 117.75 decimal land with factory shed at Kushtia are mortgaged to the Islami Bank BD Ltd. But the agreement with the Islami Bank BD Ltd. dated 02-12-2015 shows that all personal land of Managing Director and others are mortgaged. Explain about this inconsistency.

**Auditors' response:** Islami Bank Bangladesh Limited in their sanction letter dated 02.12.2015 at 'Clause number 06. Security' at page 7 mentioned that ... quote ... 117.75 decimal project land with 16094 sft factory with RCC construction under Mouza-Pipulbaria, Dowlatpur, Kustia, owned by the company .... Unquote .... is security against the loan which is mentioned in the draft prospectus.

Moreover, at page 8 of the aforesaid sanction letter, the bank mentioned **additional collateral** which included some lands owned by the Company Chairman, Managing Director and others.

35. In note 33.00 you have mentioned that related party disclosures are made as defined in the Securities & Exchange Rules, 1987. State in which paragraph related party disclosures are defined in the 'Securities & Exchange Rules, 1987'.

**Auditors' response:** The reference we mentioned is applicable to conduct the special audit of listed companies meaningfully and objectively, the audit firm appointed by the Bangladesh Securities and Exchange Commission which is mentioned in clause 2(h), SCHEDULE-2 of the Securities and Exchange Rules, 1987 **'Guidelines for conducting special audit of companies'**.
